#### HIT following the COVID-19 crisis? CIOs and HIT teams will be faced with several challenges, including acceleration of telehealth platforms, updates to the Business Continuity Plans and the associated Business Impact Analysis, and the expansion of digital health modalities for patient care. All of these changes will require robust governance and appropriate change management, both internal and external to the organization. Finally, the organizations will need to make appropriate changes to accommodate the expansion of the remote workforce. Although I listed these as challenges, they also represent a considerable opportunity to improve processes and reduce costs in ways that healthcare has not been able to envision in the past. What do you see as the biggest value of being a TN HIMSS member? 
